WIFE SLAYER ON TRIAL

Murdered Her Daughter.

John Edward Kohler yesterday faced the charge of deliberately murdering his young wife, Tillie, in the presence of her mother, in the little home of the widow parent on the corner of Broad and Pine streets. District Attorney Bolan is personally trying the case for the Commonwealth and he told the jury that the wife had been asked to come from the \$100,000 that Councils had been asked to provide as the city's share of the celebration expenses.
