

WOMAN URGES STATE TAX ON ALL BACHELORS

Mrs Charlotte Smith Tells Legislative Committee Why Men Should Wed

BOSTON, Feb. 15.—Mrs Charlotte Smith was before the legislative committee on taxation yesterday, in support of her bill providing that "every male person above the age of 21 years in this Commonwealth who is unmarried shall pay a tax of \$2 per annum to the city or town in which he resides, to be assessed in the same manner in which poll taxes are assessed, unless he can prove to the satisfaction of the assessor of the city or town in which he resides that he is not of good moral character."

It is stipulated that the fund so created shall be expended in the support of widows who have passed 60 years of age, and in the support of widows who have passed 40 years of age.
