Bitter War Opens to End Domination of Palladium Fraternities

FACULTY TO BE ASKED TO ABOLISH DISTINCTIONS

Ministry of Secret Societies Can Balk Conference, but Cannot Be Controlled by Them

Ann Arbor, Mich., January 21.—The bitter fraternal war ever waged by the Michigan campus, between the two fraternities that have been fighting to bring things to better head.

It is a war between the fraternities known as the Palladium, in the one side, as also if other societies on the other side. The fact that the Palladium fraternities have been allowed by the university senate to hold their assembly on the night sacred to the "J" hour, while the non-Palladium fraternities have been refused permission to give a dinner on that date, is one of the factors which have led to the bitterness.

Just before the faculty advised certain non-Palladium fraternities to suspend their meetings and to suspend their membership in fraternities. The fraternities which had better get to doing something if they wish to see their cause prospered.
